**General conditions of the campsite of Ilot 2018 rental location camping**  
**Document to be returned to us signed**

**Booking conditions: The reservation becomes definitive only after:**

Receipt of the signed reservation form as well as the signed general conditions form  
The receipt of the deposit: 30% of the total sum  
The confirmation of your stay by the campsite Ilot

**Conditions and rules for a camping or rental pitch:**

- The reservation is necessary by phone, mail, email or website (central reservation)
- Arrivals in camping pitches are possible every day of the week.
- The location is available on the day of arrival at the opening hours of the reception.
- For mobile homes, during the months of July and August rentals are per week from Saturday to Saturday. The rental is available on the day of arrival from 16:00 and must be vacated on the day of departure for 10:00.
- For rentals, the price does not include: sheets and linens; End of stay cleaning 50 € (retained on the deposit, if not done by the tenant)

He remaining amount is to be paid on the day of your arrival at the campsite and in its entirety according to the booking dates mentioned on the contract.

- The tourist tax is in supplement (0,44 € per day and per person from 18 years only July and August)
- No refund will be granted in case of early departure or late arrival.
- The management reserves the right to re-let the pitch in case of late arrival.
- Visitors are allowed under the responsibility of their host, after reporting their presence to the reception and paying the fee of € 3 per person.
- The client agrees to comply with the provisions of the rules of the campsite:
- The traffic of motor vehicles is limited to 10km / h and is prohibited in the campsite between 23h00 and 7h
- From 23:00, it is obligatory to respect the rest right of your neighbors.
- Insurance: CAMPING DE L'ILOT declines any responsibility in case of damage due to falling branches, storms or theft.
- It is the tenant's responsibility to take out liability insurance, damage. The campsite would not be responsible for the consequences of external events, which would have the effect of reducing or canceling your stay

All stays must be paid 30 days before the scheduled arrival date, without reminder In the absence of settlement of the balance within the time limit, the rental will be considered automatically canceled and the deposit previously paid will remain acquired by the CAMPING FROM THE ISLAND. **Except in case of force majeure: hospitalization, death, (parents or children) preventing the arrival,**

- If you wish to extend your stay (subject to availability), the additional days will be paid at the end of the day initially planned.
- The number of people must not exceed that specified, maximum 8 people per location, and between 4 and 6 people in rentals.
- **Animals** must be kept on a leash and registered at the reception as soon as they arrive with their current vaccination certificate. It is forbidden to leave the animal alone on the pitch and rentals.
- All customers are required to comply with the provisions of the rules of the campsite available at the reception.
- **Right to the image:** you authorize free camping to use photographs and videos of you and all the participants to date, which could be taken during your holidays, for the advertising needs of the campsite (site, brochure ...) and this without limitation of duration.
